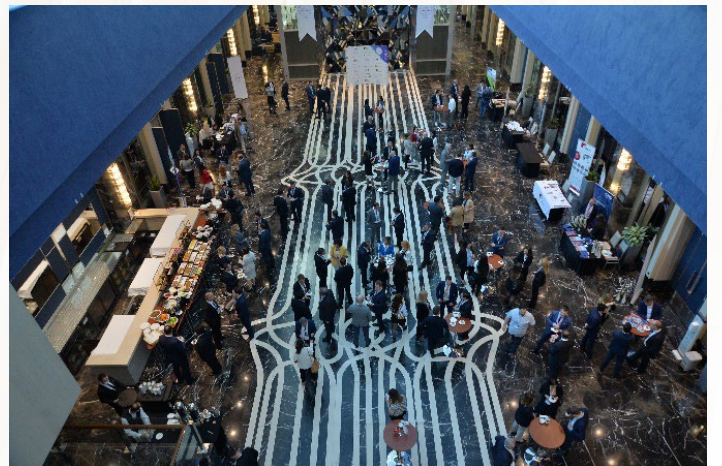
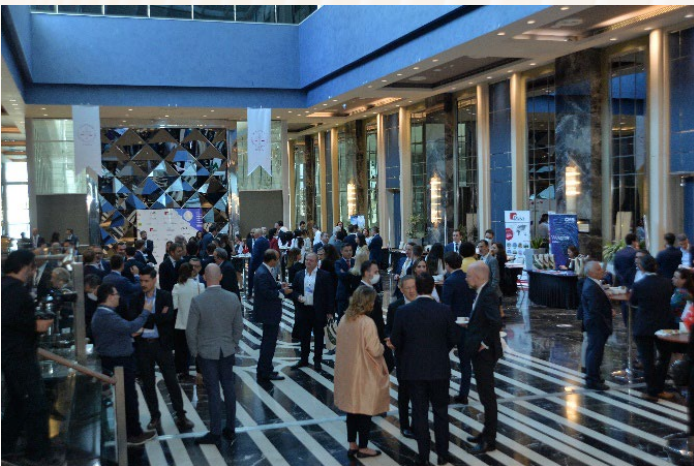


# WHY SPONSOR?

# ACCOMMODATION

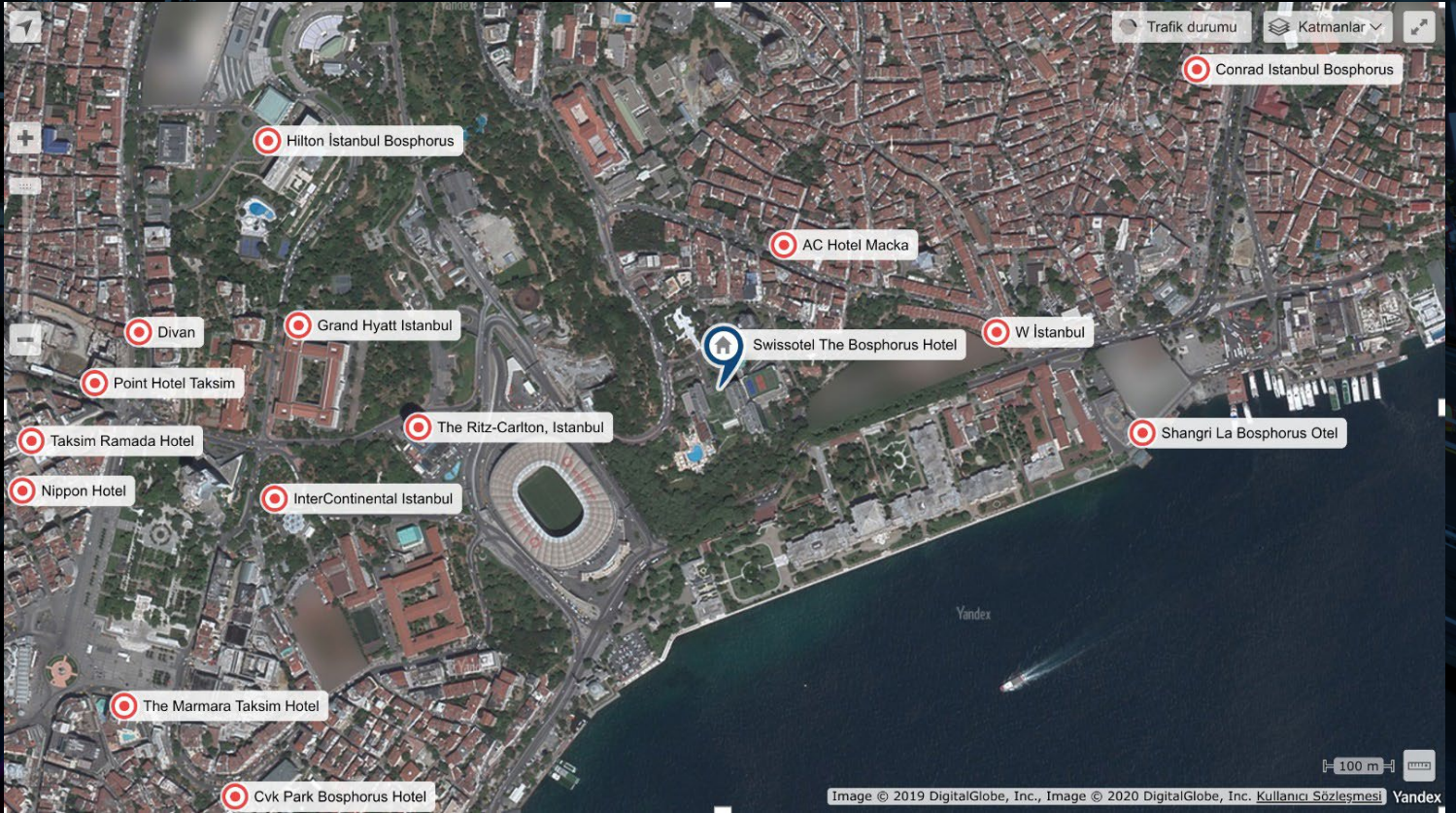
